Pastor's Message

Dear friends in Christ,

I can't say that entering ministry amid a pandemic was easy, but we have come out on the other side well-positioned for wherever the Spirit may lead us in 2024! It's difficult to believe that I have just completed my third year of ministry among you! I'm grateful for the love and care you have shown towards me during my initial years as your Pastor.

I have now "graduated" from yet another ELCA ministry requirement — First Call Theological Education (FCTE) — a three-year program for newly-rostered leaders — by attending various conferences, retreats, and bishop convocations.

As we close the books on 2023, I'm reminded of an article written back in January 2023 by Pastor Peter Marty, editor and publisher of the *Christian Century* magazine. I mentioned this article in my 2022 Pastor's report, but it bears repeating because Marty's suggestions for engaging people post-pandemic are still relevant. Here are a few of his suggestions [with some of my own wording] that have stayed with me...what about you?

- Keep our hearts wide open. Don't write off anyone's place in our community unless they insist on it.
- Despite the growing secularization of culture and rising religious indifference staring us all in the face, remember that God has given the church a bigger and better hope than what the world lives by.
- Love this Christian community as you find it, not merely as it was or as you wish it would be. There's no way to know Christ apart from Christian community!
- Welcome and accept all people for who they are.
- Share the joy that is evident here as we come together around a shared mission and purpose.
- Delight in every sign of this congregation's faithfulness!

Faithfulness abounds in this place! How do I know this? Well, this congregation has just recently embraced the idea of exploring a shared ministry arrangement with Christ Lutheran Church in Westmont. While this will be a lengthy process of discerning if the Spirit is leading us to a shared ministry arrangement, merely being open to exploration is a great example of your faithfulness as a congregation. As we move through 2024, may you continue to pray for the work of the advisory committee and keep your hearts and minds open to the stirrings of the Holy Spirit.

Finance Committee

Finance Committee, of which the treasurer shall be a member ex-officio, shall prepare a financial plan for the succeeding year, submit such plan to the Congregation Council for approval, and then present the plan at a meeting of the congregation for adoption. The committee shall exercise oversight of all financial affairs of the congregation to ensure they are being conducted with transparency and efficiency.

The finance committee counts and records offering, pays bills, keeps financial records, prepares an annual budget, exercises oversight of all financial affairs of the congregation and prepares reports for the Congregational council.

The finance committee prepares a draft spending plan each year and exercises oversight of all financial affairs of the congregation and arranges for an annual audit of the accounts. The finance committee meets the second Tuesday of every month. At this meeting, the monthly financial reports are reviewed. Members of the finance committee are responsible for recording and paying all bills, invoices, and charges. All financial records are kept electronically.

Committee members maintain the financial records in the Church 360 software package. A transition to this financial software was made in 2022. 2023 was the first full year that this software was used. This software keeps records in two separate parts which are the Members and Ledger. The "Members" package is used to record individual contributions and deposits. The "Ledger" package keeps income and expense records. These records include: account balances for our checking and investment accounts, income, and expenses. Access to these confidential records is restricted.

In 2023 the council appointed Kathie McCreary as financial secretary. The financial secretary overseas and or participates in accounting of the offerings and the depositing of receipts. The financial secretary also ensures that two non-related people are present when counting offerings. The financial secretary also oversees the recording of contributions to the individual members' records and prepares annual statements for the contributors for tax reporting.

Some notable actions of the committee in 2023 are the following:

- At the beginning of 2023 are offering envelope supplier could not deliver the envelope packages. The committee decided to cancel the order and have the office print labels and make up envelopes available for members donations. This change saved us \$550.
- December 2022, we opened a \$50,000 certificate of deposit with the Somerset Trust Company. This certificate was for a 12-month term and earned 4.5% interest. We transferred funds from our checking account which earns less than 0.1 % interest.

- We investigated companies that have E-Giving (or on-line) options. Making on-line payments for utility bills and purchases is widely used outside of church. We looked at a few companies offering this service. We contacted a company called Vanco to find out what options are available. We liked Vanco's service in part because they can link on-line gifts into our Church 360 software. The Council approved making E-Giving an option in 2024.
- We continue to use Ross Tax and Accounting Services of Windber to issue direct payroll deposits, prepare payroll tax payments, W-2's, and federal and state payroll reports.
- Pastor Rebecca advised the council of a desire purchase a house in Johnstown and move out of the parsonage. We evaluated the monetary impact to add a housing allowance to the Pastor's salary, and at the same time we learned of a local Lutheran minister who was looking for a house to rent. Synod salary guidelines include \$ 1,314 per month housing allowance for a pastor without a parsonage. We were able to lease the parsonage to Pastor Doug Knupp and his family. They moved in June and began paying \$ 1,150 per month for rent and utilities.
- The church's Appraisal was updated in September 2023. The church building and contents are valued at \$ 7.887 Million. The church insurance policy is for \$ 10 Million. We have coverage for property, liability, and other categories.

Mission Endowment Fund

In 2022, the congregation received a \$250,089.45 bequest from the William George estate. This generous bequest was used to start an endowment fund that could be used outside of the annual spending plan. A Bylaw establishing a Moxham Lutheran Church Mission Endowment Fund was approved at the November 2022 annual congregational meeting. The purpose of the endowment fund is to provide funds for internal ministries, mission work beyond the congregation and capital improvement projects. The endowment fund is used to support all three of these types of projects outside of the annual spending plan.

The organization of the Mission Endowment Fund is defined in the bylaw that was approved at the annual meeting in November 2022. The fund is managed by three trustees who were elected at that meeting. The terms of the trustees shall be up to three calendar years. Terms shall be staggered so that only one trustee is elected each year. That meant that in the first election one trustee had a three-year term, a second trustee had a two-year term, and a third trustee had a one-year term. The trustees or can be eligible to serve no more than two consecutive terms.

The trustees contacted local financial advisors to manage the investment. The trustees decided to work with Fred Thomas of Raymond James Financial Services. The trustees also decided to invest in fixed rate Certificate of Deposits and money market funds. Both types of investments are insured by the Federal Deposit Insurance Corporation (FDIC). The investments selected earn between 4.2 and 4.8% annually.

Income from the investments shall be used for designated purposes such as internal ministries designated by the congregational council. The 2024 spending plan included a transfer of \$ 10,100 in income to be made available to spend in 2024.

The 2023 Trustees are Dennis Kotzan, 3-year term; Dan Berkebile, 2-year term; and Phil Newbaker, 1-year term. Phil Newbaker requested to not be reelected. At the 2023 Annual Congregational meeting, Randy Lear was elected to a 3-year term beginning in January 2024.

Treasurer's Report

The attached Balance Sheet shows that our assets on January 1, 2023, were \$ 473,889.22. The Year-end balance on December 31, 2023, is \$ 462,579.26, a reduction of \$ 11,309.96. The Balance Sheet shows the funds in our various accounts which include restricted and unrestricted funds. In 2023 we received \$ 19,715.46 in restricted bequests gifts which helped increase the year-end balance.

In addition to a checking account, we have set up investment accounts to earn more interest income on our cash. These investments are with ELCA Mission Investment Fund and a 12-month Certificate of Deposit with Somerset Trust.

The attached Income and Expense Report shows the 2023 spending plan(budget) and actual expenses. The approved spending plan exceeded the anticipated income from giving. To "balance" the 2023 spending plan we planned to use \$ 13,524.74 from cash. At the end of the year the expenses exceeded giving and other income by \$ 26,600.07

We spent considerable time developing the 2024 Spending Plan. Each Committee, the Pastor and the office are asked to prepare a budget. We also projected other expenses such as insurance, utilities and salaries. The 2024 Spending Plan was approved at the Annual Congregational meeting on November 19,2023.

As treasurer, I also met with the Trustees for our Moxham Lutheran Mission Endowment Fund which was created at the annual meeting November 2022. There is a separate report on the Moxham Lutheran Mission Endowment Fund.

In summary, last year our congregation continued to get smaller. However, we can continue in our mission because you, our members, are generous and caring. We look forward to 2024.

Human Resources

Denise continues here employment as the church administrative staff person. She has had her annual review.

Landscape Team (ad hoc)

The Church Council created the Landscape Team in 2022 as an ad hoc committee whose goal is to consider all landscape areas around the church and make recommendations to Council on ways to improve and maintain them.

In 2022, the team studied the landscaping areas and noted ideas on types of vegetation for each one, specifically considering looks, growth and care over time, and placement (soil, light, etc.). In late spring 2023, we met with Stuver's Nursery for ideas and proposals, then decided to postpone major landscaping until 2024.

Throughout 2023, all areas were cared for to some extent- weeding, trimming or pulling out plants, and mulching. Thanks to the Property Committee and other individuals who helped. After meeting again with Stuver's for specific designs and costs in 2024, our recommendations will be presented to Council.
